Whereas **District Institute of Education and Training, PO- Chhandar, City – Bankura, Dist – Bankura, West Bengal – 722203** has made application for grant of recognition for **D.Ed. course** to Eastern Regional Committee on 28.10.2009.

Whereas an inspection team was constituted by ERC-NCTE, which visited the institution on 15.11.2010 & 16.11.2010 to verify infrastructural and instructional facilities provided by the institution and also the essential documents as per NCTE Regulation.

Whereas report of the inspection team was placed before the Eastern Regional Committee in its 113th meeting held on 19th – 20th November 2010.

And whereas on careful perusal, observation and consideration of the proposal of the institution along with the original file, Original VT Report, Video CD, all documents submitted by the institution, office observation & remarks, related clarifications/ guidelines received from the NCTE Hqrs., the NCTE Act, Rules, Regulations 2009 stipulated by the NCTE, norms and standards, the ERC decided as follows:-

- (i) The Principal is advised to obtain the land certificates from the concerned (competent) authority as per the NCTE norms.

The institution is also requested to clarify the following points.

- (i) Approved building plan with Plot No., Khata No, Khesra No, Total area, not from competent civil authority.
- (ii) Notarized copy of change of land use certificate issued by the competent authority.
- (iii) Undertaking not submitted in the prescribed format.
- (iv) Non-encumbrance Certificate from Revenue Authority.
- (v) Enclosure regarding column 5 of the affidavit not submitted.
- (vi) Building completion certificate with the Plot number, Khata No., total area & built up area from competent civil authority not submitted.
- (vii) All Plot no.s are mentioned in land documents and affidavit do not tally with each other.

And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirement, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.

Whereas **Bakreswar Teacher Training Institution, Vill & PO – Hetampur Rajbati, P.S. – Dubrajpur, Dist – Birbhum, West Bengal – 731 123** has made application for grant of recognition for **D.Ed. course** to Eastern Regional Committee on **27.10.2009**.

Whereas an inspection team was constituted by ERC-NCTE, which visited the institution on **12.11.2010** to verify infrastructural and instructional facilities provided by the institution and also the essential documents as per NCTE Regulation.

Whereas report of the inspection team was placed before the Eastern Regional Committee in its 113th meeting held on 19th – 20th November 2010.

And whereas on careful perusal, observation and consideration of the proposal of the institution along with the original file, Original VT Report, Video CD, all documents submitted by the institution, office observation & remarks, related clarifications/ guidelines received from the NCTE Hqs., the NCTE Act, Rules, Regulations 2009 stipulated by the NCTE, norms and standards, the ERC decided as follows:-

- i. Covered area mentioned in the building plan is not as per norms.
- ii. As per building completion certificate the 60-70% of the building is complete.
- iii. One plot No mentioned in the print out of the application is 403 whereas the plot No. stated in the affidavit is 251/337 and Hall Plot No. 347 and in the land document plot No. mentioned are 251/337 Hall Plot No. 347. Hence, there is contradiction in the plot no of the print out of the application and the land documents.
- iv. The letter dated 02.02.2010 issued from the Revenue Officer is not treated as CLU. The institution has to clarify the same.
- v. Affidavit of Rs.100 stamp paper is incomplete and after due date.
- vi. The Multipurpose hall is not as per NCTE norms.

And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.

Whereas an inspection team was constituted by ERC-NCTE, which visited the institution on **29.10.2010** to verify infrastructural and instructional facilities provided by the institution and also the essential documents as per NCTE Regulation.

Whereas report of the inspection team was placed before the Eastern Regional Committee in its 113th meeting held on 19th – 20th November 2010.

And whereas on careful perusal, observation and consideration of the proposal of the institution along with the original file, Original VT Report, Video CD, all documents submitted by the institution, office observation & remarks, related clarifications/ guidelines received from the NCTE Hqrs., the NCTE Act, Rules, Regulations 2009 stipulated by the NCTE, norms and standards, the ERC noted that the land & built up are as per norms and V.T. report is positive but the following deficiencies are still exist:-

- i. The institution has not submitted certified land document.
- ii. The land is not in single plot.
- iii. The affidavit of Rs.100 contains the Plot No.3657, 3880, 3641, 4811, 5625, 5647, 5898, 5899 and 5605 where as the translated version of the land document (Gift deed) describes the plot of Nos.4811(Khatian No.284, 816, 2093), 5605, 5603, 6137 only.
- iv. Notarized Copy of Permission for change in use, character of land dt. 19.03.2010, which is after submission of on-line application.
- v. Downloaded Copy of application in triplicate in Prescribed Format.
- vi. Approved building plan with Plot No., Khata No., total area and built up area from competent civil authority.
- vii. Non-encumbrance certificate from Revenue Authority.
- viii. As per Gift Deed it is executed between individuals. The gift deed is also conditional. Further the total area mentioned is 117 Dec. i.e.

Plot 4811	-	76 Dec.
Plot 5605	-	21 Dec.
Plot 5603	-	20 Dec.

Plot 6137 (New) 117 Dec.

Two plot Nos. i.e. 4811 and 5605 are reflected in the land document which are in favour of the individual. The V.T. has also not mentioned about the particular gift deed. The institution is required to clarify the same.

- ix. As per VTR the CLU is for plot/khata no.5721 only. The building plan in light of the area of plot no. 4811 given in two different deeds appears to be tampered.
- x. Further it is also observed that the name of the authorized signatory of the application i.e. Sofiuzzaman Saikh is not reflected in the society. The same person is representing society / has executed the gift deed as representative of society.
- xi. The multi purpose hall as per VT is 1872 sqft.

And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.

Now therefore, as per the Section 14(3)(b) of NCTE Act, 1993, before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation within **30 days** of issue of this notice along with the supporting documents.

In the event of this office not receiving representation within **30 days** from the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Regional Committee shall take decision as it deems fit and proper.
