Sub:- **Maintenance of website and information to be furnished by the all recognized institutions – reg.**

Sir,

As per clause 8(16) of NCTE Regulations 2009, the institutions recognized by NCTE are required to adhere to the mandatory disclosure in the prescribed format and display up-to-date information about their institution on its official website. Again, as per clause 8(9) of NCTE Regulations, the affidavit regarding land, including a copy of the land documents submitted by the institution for the recognition purpose are also required to be displayed on the official website. It has also been made clear in the Regulation that if the contents of the affidavit is found to be incorrect or false, the applicant society or trust or the institution concerned shall be liable for civil and criminal action under the relevant provisions of the Indian Penal Code, including withdrawal of their recognition, by the respective regional committee. Any wrong or incomplete information on website also shall render the institution liable for withdrawal as per Regulations 2009.

2. In view of above provisions, regional committees are requested to ensure that intimation be sent to all the recognized institution, through a public notice and notice on the website of the committee that the institutions must update their website with all the details and documents as specified in the NCTE Regulations, 2009. While doing so, the institutions also need to be requested that their website must contain a photo gallery having photographs showing following details :-

- i) Front elevation of the Institution Building.
- ii) Two side elevations of the Institution building depicting location of the institutions in its surroundings.
- iii) Group photo of the Faculty, in addition to individual Profile of the Faculty with Photograph.
- iv) Photos showing important infrastructure facilities of the Institution e.g. multipurpose hall, Library, Laboratories etc.

3. The institution be requested to update their website accordingly, within a period of three months with intimation to the concerned Regional Committee; which would hyperlink the website of the institutions with its own website under the "list of Recognized Institutions".

4. The Regional Committees are also directed that in case of new institution the hyperlink of the institution's websites must be ensured, before issuing the formal recognition order of the institutions.

A Notice for the purpose may also be placed on the website of the each Regional Committee for the purpose, under intimation to this office.
