

**PROCEEDINGS OF 110<sup>th</sup> MEETING OF EASTERN REGIONAL COMMITTEE HELD ON 15<sup>th</sup> -16<sup>th</sup> July 2010**

The 110<sup>th</sup> Meeting of the Eastern Regional Committee (ERC), National Council for Teacher Education (NCTE) was held on 15<sup>th</sup>-16<sup>th</sup> July 2010 at Conference Hall, ERC, NCTE, Bhubaneswar, Orissa.

The Committee in the presence of Member Secretary, NCTE-HQrs deputed as observer unanimously decided that Prof. Anirudh Singh shall preside the meeting as the acting Chairperson in the absence of Chairperson-ERC.

The Sub-Group of the Eastern Regional Committee in the presence of Member Secretary, NCTE-HQrs perused & considered all the cases and taking into consideration the recommendations made by the Sub-Group, the Eastern Regional Committee considered & decided the following matters/cases as per the proceeding noted below:-

The Committee recalled the discussions in respect of these seven institutions and decided that since in the 107<sup>th</sup> meeting a specific decision was taken in respect of these institutions, in the presence of Chairperson-ERC and as reported in the minutes of 107<sup>th</sup> meeting, there was no occasion to reverse the decision taken in absence of the Chairperson. The decision taken was to refer these cases again to Chairperson-ERC with further developments that had taken place after 107<sup>th</sup> meeting to take a view. The committee, therefore, decided to amend the minutes of 109<sup>th</sup> meeting accordingly. The Committee further authorised the Chairperson-ERC to review the decision in respect of each of above seven institutions and decide further course of action without placing the matter again before ERC.

The Committee further decided that office of ERC may take action as per the decision to be taken by the Chairperson – ERC without waiting for the next meeting and the action taken report on the above be placed before the ERC in its next meeting.

Further, upon consideration of the matter, original files of the following institutions, NCTE Act, Rules, Regulations and guidelines of NCTE-HQrs published from time to time, the Committee also ratified the action taken by ERC office to issue show cause notice section 14 (3) (b) and section 17 in respect of the following institutions, where Committee decided to refuse the recognition/ issue clarification letter in case of recognised institutions. The reply to Show Cause Notice be placed before the Committee in its next meeting.

<p>The Committee endorsed the action taken by RD-ERC on the directions issued by NCTE-HQrs in cancelling the inspection scheduled from 10<sup>th</sup> July 2010 onwards in view of number of inspection to one member / team exceeding five as per the VT policy.</p> <p>The convenor further placed before the Committee that in the 107<sup>th</sup> meeting of ERC, decision taken in respect of 87 institutions was to conduct inspection of all these institutions, even though many of them had deficiencies as per Regulations 2009, including those under Section 7 (i). Since the inspection has been conducted only in case of 42 institutions, the matter regarding remaining 40 institutions wherein the inspections were cancelled were placed before the Committee for a review. The agenda note in respect of 40 cases, as placed in 107<sup>th</sup> meeting was placed again before the Committee.</p> <p>The Committee again considered the entire matter and decided that the decision taken in 107<sup>th</sup> meeting held on 5<sup>th</sup>-8<sup>th</sup> May 2010 in respect of all institutions except seven institutions referred in Agenda Item No. 110.1 above be implemented forthwith. The Committee strongly felt that any going back on the decision of 107<sup>th</sup> meeting would put NCTE in embarrassment and increase legal complications. As such, they reiterated their earlier decision in respect of these 40 institutions without going into the merit of individual cases again.</p> <p>The Committee constituted VT in respect of these 40 institutions with direction to the office to issue letters to the VT team so constituted, so as to complete the inspection in respect of all these 40 institutions before 31<sup>st</sup> July 2010.
