In view of the above the committee decided as under:

DLI be issued to the institution and copy of the same be forwarded to Commissioner-cum-Secretary, School and Mass Education, Govt. of Odisha, Bhubaneswar and Director, TE & SCERT, Govt. of Odisha, Bhubaneswar for information and necessary action.

After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., letter dt. 03.09.2012 and 12.09.2012 from the institution in response to show cause notice, the Committee discussed the matter in detail and observed as under:

- (1) The letter No. XII-SME(Trg.)12/2012-20819/SME dated 13 August 2012 from Special Secretary from Govt of Orissa, Department of School and Mass Education informed the decision of the Government for grant of NOC for starting of B.Ed. course by School of Bachelor of Education, being run by Jagannath Institute and Technology and Management Trust, Paralakhemundi, Gajapati. The State Government in its letter cited as follows:
  - (i) The Centurion University of Technology and Management is a Self-financed private University.
  - (ii) Opening of Private B.Ed. Colleges and Secondary Training Schools in the State has been banned with effect from 14.08.1989 under the provisions of Sections 7-E and 7-F of the Orissa Education (Amendment) Act, 1989. Sections 7-E and 7-F stipulate the following:
    - **Section-7-E** "Notwithstanding anything to the contrary contained in this Act, on and after the commencement of Orissa Education (Amendment) Act, 1989, the State Government shall not accord permission for establishment of any private Secondary Training School or private training College or recognize any such school or college established, if any, prior to the said date".
    - **Section-7-F** "Notwithstanding anything contained in this act or the rules made there under or any judgment, Decree or order of any Court the State Government shall not be bound to accord permission for establishment of any such private secondary training school or private training college or recognize any school of college established, if any, prior to the 14th Day of August 1989 and non recognition of such school or college shall not be questioned in any court of law or otherwise be opened to challenge.
  - (iii) In view of the aforesaid statutory provisions, the proposal for grant of NOC in favour of the petitioner-university was rejected by the School and Mass Education Department vide letter No. 1526/SME dt. 17.01.2012.
  - (iv) School & Mass Education Department, Government of Odisha have also decided to increase the intake capacity of the existing Teacher Training Institutes in intake capacity of existing Teacher Training Institutes in the State of Odisha. In this connection, letter No. 10763 dtd. 25.04.2012, addressed to Director, TE&SCERT, Odisha, with copy to Regional Director, ERC, NCTE, Bhubaneswar may please be referred to.
  - (v) Apart from the above, ST & SC Development Government, Government of Odisha have established one B.Ed College at Kandhamal and have also decided to establish 5 new Training College in the districts of Malkangiri, Nawarangapur, Rayagada, Mayurbhanj and sundargarh.

(vi) Thus, the requirement of B.Ed. qualified candidates can be met by the Government B.Ed. Colleges in the State of Odisha.

After careful consideration, the State Government is of the view that the recognition for starting new B.Ed. course may not be granted in favour of the Jagannath Institute for Technology and Management Trust, Paralakhemundi, Gajapati (under the Petitioner-University).

In view of the above, the committee decided as under:-

The recognition for B.Ed. course of the institution is refused under section 14(3)(b) of NCTE Act, 1993.
