As per 8(3) of the NCTE Regulation 2009, an institution can apply for one basic unit only of an additional course or for an additional unit of the existing recognized course after completion of three academic sessions of the respective course, for which the institution shall submit application before the cut-off date prescribed for submission of applications in the year succeeding the completion of three academic sessions.

In view of the above, the committee decided to close the application Code No. ERCAPP861. The institution be informed accordingly.
