The Committee therefore, provides an opportunity under section 14(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 30 days from the issue of the letter before the Committee takes final decision.

After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs, VTR and reply dated 12.12.2012 in response to show cause notice after VT, the Committee discussed the matter in detail and observed as under.

1. As per application submitted online, the name of the institution and the name of the trust is same i.e. Brajesh Kumar Foundation.
2. During inspection, it is observed by the VT experts that the name of the institution is Ganga Global Institute of Teacher Education. It is also confirmed from the CD submitted by the institution in response to the show cause notice.
3. The institution be asked to submit the clarification on the points mentioned above.

In view of the above the committee decided as under:

Show cause notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides an opportunity under section 14(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 30 days from the issue of the letter before the Committee takes final decision.
