The committee observed that Shri Shri Avijit Chakraborty, Advocate, High Court of Calcutta has made complaints against the Agnibina School of Education on 07.11.2013 and same was withdrawal by him vide letter dated 30.11.2013 stating as under:

I am sorry to say that the complain was totally fake and anyhow I was misguided by my fake client Golam Mortaza, in this connection I am praying for pardon and apology and also admitted that I was visited the said college and astonished that everything is sufficiently present there and there is no existence of his client as because he made him fool.

Shri Avijit Chakraborty, Advocate has also made the complaints against two more institutions namely Matari D Ed College & Jangal Mahal Teachers Training Institute.

The committee considered the complaints made by Shri Avijit Chakraborty, Advocate and discussed at length in the matter and observed that Shri Avijit Chakraborty is habitual complainer and made the false complaints against the several institutions.

Keeping in view the above the committee decided to ignore all the complaints made by Shri Avijit Chakraborty and to inform the Bar Council of Hon'ble High Court of Calcutta regarding his habit of making false complaints against the institutions and misleading the NCTE in the process of taking appropriate decisions.
