HELD ON 27th February to 3rd March, 2017**

As per the notice for meeting issued by this office, the 234th meeting of ERC is scheduled to be held from 27th February, 2017 to 3rd March, 2017. The Chairperson, ERC contacted telephonically and informed that due to some personal engagement he is unable to attend the meeting on 27th February, 2017 and directed to continue the meeting in his absence.

Under the circumstances, the members of ERC considered that the last date 3rd March, 2017, as stipulated by the Hon'ble Supreme Court and NCTE Regulation, 2014, is approaching and every minute is crucial in view of the huge pendency. The members present in the meeting hereby unanimously decided that in absence of Chairperson, ERC, Dr. Shukla Mahanty, Member, ERC shall function as a Chairperson.
