Now, this Veer Kunwar Singh College of Education made one lease deed on 15.12.2008 in the name of Veer Kunwar Seva Sansthan i.e. without concerning with the Governor of Bihar.

It appears that the lease deed was made between private to private party which is not acceptable as per NCTE Regulation 2014".

- (ii) The institution vide representation dated 11.01.2017 has requested for extension of six weeks time to comply the reply of SCN.
