

**PROCEEDINGS OF 257<sup>th</sup> MEETING OF THE ERC-NCTE**  
**HELD ON 02<sup>nd</sup> – 3<sup>rd</sup> July, 2018**

The 257<sup>th</sup> Meeting of the Eastern Regional Committee (ERC), National Council for Teacher Education (NCTE) was held on 2<sup>nd</sup>-3<sup>rd</sup> July, 2018 at Conference Hall, ERC, NCTE, 15, Neelakantha Nagar, Nayapalli, Bhubaneswar. As per decision of 256<sup>th</sup> ERC Meeting, reasoned order dated 11.06.2018 was issued to the institution with the following observation and informing that the previous order for one basic unit 50 intake of D.El.Ed. from the academic session 2016-2017 to the institution issued vide order dated 02.05.2016 remain unchanged.

- (i) The institution submitted approved faculty list (1 HOD + 13 lecturers) for 50 intake (One Unit) only instead of required 1 HOD + 15 lecturers for 100 intake (Two Units) as per NCTE Regulations, 2014. Hence, the decision of ERC taken in 213<sup>th</sup> meeting granting recognition for 50 intake in D.El.Ed. programme remains unchanged.

The NCTE Hqrs vide its letter dated 29.05.2018 requested to consider the petitioner case in the RC meeting as per the provisions available under NCTE Act and Regulation.

In response to ERC reasoned order dated 11.06.2018, the institution submitted representation dated 12.06.2018.

**The ERC re-viewed the matter in accordance with above and observed as under:-**

- (i) The institution is asked to submit consolidated approved faculty list mentioning faculty list 02 teachers who will be act as on sharing basis in D.El.Ed. programme.

**In view the above, the Committee decided as under:**

Show Cause Notice be issued to the institution for the above point. The Committee therefore, provides opportunity under section 15(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.

The institution was granted recognition for D.El.Ed. course with an intake of 50 (one basic unit) from the academic session 2017-2018 vide order No. ER-218.6.15/ERCAPP3772/D.El.Ed./2016/48613 dated 29.07.2016 by the ERC, NCTE.

Being aggrieved, the institution preferred appeal and the appellate authority vide its order dated 03.01.2017 confirmed the ERC order dated 29.07.2016 which was noted by ERC in its 233 meeting held on 17-18 February 2017.

The institution filed W.P. (C) No 3021 of 2017 in the High Court of Delhi. The Hon'ble High Court disposed of the

matter on 23.05.2018 with a direction inter alia:

*“Having heard the learned counsels for parties, I am of the considered opinion that, in view of the admitted position that till date no order has been passed by respondent no. 2 in respect of the second Unit, the impugned order of Eastern Regional Committee of the NCTE taken in its meeting held between 11/12<sup>th</sup> July, 2017 as also the order dated 3<sup>rd</sup> January, 2017, dismissing the petitioner’s appeal, are wholly unsustainable. Accordingly, the decision of order dated 3<sup>rd</sup> January, 2017, is set aside and the matter is remanded back to the respondent no. 2 for considering the petitioner’s request for seeking recognition of the second Unit for D.El.Ed. course. The respondent no. 2 is directed to decide the petitioner’s aforesaid request by passing a reasoned and speaking order within twelve weeks.*

*The petition is disposed of in the aforesaid terms.*

*Needless to say, in case the petitioner is aggrieved, it will be open for the petitioner to take recourse as permissible under law.”*

The order passed by the Hon’ble Court was received from NCTE Hqrs., New Delhi through e-mail / letter dated 28.05.2018 to consider the petitioner’s case as per the provisions of NCTE available under NCTE Act and Regulations. The institution vide its letter dated 01.06.2018 requested to grant Additional one Unit (50 students) of D.El.Ed. course. Accordingly, the Committee considered the aforesaid matter and observed as under:

- (i) The submitted building plan and the building completion certificate having 3916 sq. mts. built up area. Thereafter, the institution again submitted another building plan and building completion certificate approved having 105 sq. mts. Built up area which contain garage and canteen which is not accepted and approved as total built up area as per Regulation 2014. Hence, the decision taken in 218<sup>th</sup> ERC meeting granting recognition for 50 intake in D.El.Ed. programme remain unchanged.

**In view of the above, the Committee decided as under:**

A reasoned and speaking order stating the above position be issued to the petitioner institution.

The institution was granted recognition for B.Ed. course with an intake of 50 (one basic unit) from the academic session 2017-2018 vide order No. ER-227.6.40/ERCAPP3832/B.Ed./2016/51015 dated 17.01.2017 by the ERC, NCTE.

Being aggrieved, the institution filed W.P. No 4244 of 2018 in the High Court of Delhi. The Hon’ble High Court disposed of the matter on 27.04.2018 with a direction inter alia:

*“Keeping in view the contentions raised by the learned counsel for the petitioner and orders passed by this Court, the respondents are directed to treat the present writ petition as a representation and decide the same by passing reasoned and speaking order within eight weeks.*

*Needless to say in case, the petitioner is still aggrieved by the said order, it will be open for the petitioner to take legal recourse permissible under law.”*

The order passed by the Hon’ble Court was received from the institution vide its letter dated 21.02.2018 received on 07.06.2018 wherein requested for grant of Additional one Unit (50 students) for B.Ed. course.

**The Committee considered the Order of the Hon’ble Court as well as letter from the institution and decided as under:**

In addition to 50 intake already granted for B.Ed. course from the academic session 2017-18 earlier, the Committee decided that formal permission order under clause 7(16) of the NCTE Regulation, 2014 for applied **B.Ed. Programme** with another **50 intake** from the session **2019-2020** be issued to the institution, thus making the **sum total grant of 100 intake.**

No 6531 of 2016 in the High Court of Delhi. The Hon'ble High Court disposed of the matter on 28.02.2018 with a direction inter alia:</p> <p><i>“Keeping in view the provisions of para 6.1 of the NCTE Regulations as also the fact that the petitioner's appeal has been rejected on the ground of non-supply of documents demanded from him, copies of most of which were already available with the respondents, I deem it appropriate to grant one last opportunity to the petitioner to once again submit the requisite documents to the respondent no.2.</i></p> <p><i>Accordingly the orders dated 2<sup>nd</sup> June 2016 and 6<sup>th</sup> November 2015 passed by the respondent no.1 &amp; 2 respectively are quashed. The institution filed W.P(C)No.5460 of 2016 in the High Court Delhi and the Hon'ble Court disposed of the writ petition on 02.06.2016 which was considered by ERC in its 217 meeting held on 29-30 June 2016 wherein the ERC decided that the institution file be closed and the institution be advised to apply afresh for consideration of its application for the next academic session.</p> <p>The order dated 18.04.2016 of the Appellate Authority was noted by ERC in its 219 meeting held on 22-23 July 2016.</p> <p>Again, the institution filed a WP(C) No.7597/2016 in the High Court of Delhi and the Hon'ble Court disposed of the matter on 23.02.2018 with a direction inter alia:</p>		

*“The writ petition is allowed and the impugned orders dated 22.07.2016 passed by respondent No. 2 is set aside. Subject to the petitioner meeting all other prescribed criteria, the respondents are directed to process the petitioner’s application for recognition for the D.El.Ed course for the academic year 2018-19 on or before 03.03.2018.”*

The Court order dated 23.02.2018 passed in W.P. (C) No 7597 of 2016 was sent to NCTE Hqrs through e-mail dated 12.04.2018 and the NCTE Hqrs vide its e-mail dated 16.05.2018 instructed in tabular format stating the application of petitioner to be considered in ERC Meeting. Accordingly, the Committee considered the aforesaid matter and decided as under:

<p>2. In response to Show Cause Notice, the institution vide reply dated 23.02.2016 has submitted two land documents, one is gift deed and another is sale deed. Gift deed has been registered on 17.02.2016 i.e. after submission of the online application. Initially the institution has submitted documents of land for 66.63 Dec. (2700 Sq. Mts.), which is less than the required land for composite courses (B.Ed. and D.El.Ed.).</p> <p>B. As per the direction of Hon'ble Supreme Court and NCTE Hqrs. letter dt. 28.06.2018 the matter was placed before the committee for further processing and after careful observation; it was found that the submitted land documents such as Mutation, Conversation, Non-encumbrance and land possession certificates are not clearly mentioned in the name of institution.</p> <p><b>In view of the above, the Committee decided as under:</b> Show Cause Notice be issued to the institution as to why the application for grant of permission for applied D.El.Ed. course be not refused on the above points.
