- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- The institution shall submit the Eastern Regional Committee a Self-Appraisal 5. Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update the Web-site as per provisions of 7. NCTE Regulations including inter-alia:

  - Land and Building Particulars
  - iii. Staff Profile
  - iv. Recognition letter
