Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Govt. Teachers' Training College, Saharsa, Plot No. – 08, Street-Kachari, Vill./Po- Saharsa, Tehsil/Taluka- Saharsa, Dist. – Saharsa, Bihar – 852201 has submitted an application (**Code No. ERCAPP925**) to the Eastern Regional Committee of NCTE for grant of recognition for conducting B.Ed Course with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 9/17/2011 and hard copy of application submitted on (mm/dd/yyyy) 10/7/2011.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education (B.Ed) programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. AND WHEREAS the Eastern Regional Committee in its 135th meeting held on 17th -18th June 2012 considered the matter and decided as under:

"After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE HQR, VTR Report and letter from Principal Secretary Education Govt of Bihar, the Committee discussed the matter in detail and decided as under:

Formal recognition order under clause 7(11) of the NCTE Regulation 2009 for the applied course D.El.Ed. with an intake of one basic unit of 50 from the academic session 2012-13 may be issued to the institution."

4. AND WHEREAS the Eastern Regional Committee in its 136th meeting held on 4th – 6th July 2012 while confirming the proceedings of 135th ERC meeting decided as under:

"Proceedings of the 135th ERC meeting confirmed with the following modification:

The following corrigendum is made to the 135th ERC decisions:

- a. In respect of application ERCAPP925 at Sl.No. 66, ER-135.6.17, the part "course D.El.Ed. with an intake of one basic unit of 50" be read as "course B.Ed. with an intake of one basic unit of 100."

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **Govt. Teachers' Training College, Saharsa, Plot No. - 08, Street-Kachari, Viil./Po- Saharsa, Tehsil/Taluka- Saharsa, Dist. - Saharsa, Bihar - 852201** for conducting **B.Ed.** Course of **Secondary** (level) of **one year** duration with an annual intake of **100 (one hundred)** from the academic session **2012-2013** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

6. The recognition is subject to fulfillment of the following:

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- (iv) All such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- (v) The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- (vi) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - a. Copy of the Application Form
 - b. Land and Building Particulars
 - c. Staff Profile
 - d. Recognition letter
 - e. Information for having fulfilled the norms & standard and other required conditions.


7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

8. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order.
