ORDER

Change of premises of the institution

Patliputra Teachers' Training College, Ali Nagar, Maulana Azad Engineering College, Anishabad, Dist- Patna, Bihar – 800002 (Code No. APE00577) granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order No. ERC/7-87.6(i).19/2008/11883 dt. 04.08.2008 as per decision taken in the 87th ERC meeting held on 23-25 July, 2008 and subsequent Order vide No. ERC/NCTE/APE00577/B.Ed.(Revised order)/2015/32322 dt. 28.05.2015 issued as per NCTE Regulation, 2014.

The aforesaid institution had submitted application dated 28.05.2015 for shifting of premises along with requisite documents.

The ERC in its 199th meeting decided that VT to be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 31.01.2016 and VT report received at ERC, NCTE on 08.02.2016.

The ERC in its 204th meeting was held on 15th – 17th February 2016 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqs from time to time and VTR, the Committee discussed the matter in detail and decided as under:

"Shifting is permitted".

In view of the above, the institution is hereby permitted shifting of premises of the institution from "Patliputra Teachers' Training College, Ali Nagar, Maulana Azad Engineering College, Anishabad, Dist- Patna, Bihar – 800002" to "**Patliputra Teachers' Training College, Patna, Plot No. 167, 170, 174, 145, Madhopur (Nehura), Phulwari Sharif, Patna-801505, Bihar**".




