Order

WHEREAS Sri B.P.Singh Mahila Prathmik Shikshak Shiksha Mahavidyalaya, Lakhanchand, Mokama Ghat, Patna, Bihar-803303 was granted recognition for Elementary Teacher Education Course from the Academic session 2002-2003 with an annual intake of 50 (Fifty) students vide ERC order No.ERC/7-23/2002/1133 Dt.09/12 April 2002.

2. AND WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Sri B.P.Singh Mahila Prathmik Shikshak Shiksha Mahavidyalaya, Lakhanchand, Mokama Ghat, Patna, Bihar-803303 has submitted an application (Code No. ERCAPP965) to the Eastern Regional Committee of NCTE for grant of permission for Additional Intake of D.El.Ed Course in the existing annual intake of 50 (fifty) by online on (mm/dd/yyyy) 9/21/2011 and hard copy of application submitted on (mm/dd/yyyy) 10/7/2011.

3. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Elementary Teacher Education (D.El.Ed) programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly-qualified teaching staff as per-NCTE norms.


4. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants permission to **Sri B.P.Singh Mahila Prathmik Shikshak Shiksha Mahavidyalaya, Lakhanchand, Mokama Ghat, Patna, Bihar-803303** for conducting **D.El.Ed. Course of Elementary (level) of two year duration with an additional annual intake of 50 (fifty), thus making the total annual intake of 100 (one hundred)** from the academic session **2012-2013** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

5. The recognition/permission is subject to fulfillment of the following:
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - The institution shall ensure that the required number of academic staff for conducting the course is always in position.
 - All such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

- (v) The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- (vi) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
- Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition/permission letter
 - Information for having fulfilled the norms & standard and other required conditions.

6. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition/permission as under the provisions of Section 17(1) of the NCTE Act.

7. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order.
