Order

In terms of Section 14(1) of the NCTE Act, 1993 Millat Teachers Training College, Madhubani, Bihar, Pin-847 212 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting E.T.T.C. Course of Two years duration from the academic session 2004-2005 with an annual intake of 250 (Two hundred fifty) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution and it proposes to function from its own building.
- ii) The institution has created an Endowment Fund of Rs.5.00 lakhs and no Reserve Fund.
- iii) The institution has selected the Principal/ Head and 20 (twenty) full-time teachers for the said course and the list of faculty members has not been approved by the affiliating body i.e. Bihar School Examination Board, Patna.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Millat Teachers Training College, Madhubani, Bihar, Pin-847 212 for E.T.T.C. Course of Two years duration from the academic session 2004-2005 with an annual intake of 120 (One hundred twenty) students subject to fulfillment of the following:

- a) That the institution will ensure that Principal/ Head and at least 11 (eleven) faculty members duly approved by the affiliating body are in position for an intake of 120 students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of the commencement of the course.
- b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- c) The institution shall deposit the amount in reserve fund as per NCTE norms and a confirmation to this effect shall be sent to the ERCC within one month from the commencement of the academic session.
- d) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.


4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


