Order

WHEREAS, **Rashidiya Rani Sagari Teacher's Education College, At – Chand Bajitpur, Po/Ps – Belaganj, Dist – Gaya, Bihar – 804403** (Code No. APE00781) had applied for grant of recognition for **PTT (D.Ed.)** Course of two years duration under Section 14 of the NCTE Act, 1993 to the ERC, NCTE on dt.19.01.2007.

2. AND WHEREAS upon consideration of the written representation submitted by the institution as well as documents as well as other documents and materials submitted by the institution along with application the Eastern Regional Committee in its 100th meeting held on 26th-28th Aug 2009, came to the conclusion that recognition to the said institution be refused for the following reasons:

- I. The institution has not appointed requisite number of teaching staff qualified as per NCTE norms.
- II. Affidavit Rs. 100/- & Rs. 10/- stamp paper regarding teaching staff not submitted by the institution.
- III. The website of the institute is available but it does not have the Internet connection. And also on seeing of the website it is found that the site is suspended not functioning which is not as per Regulation.
- IV. The land and building of the institution are not in the name of the institute but on lease from a Private Person, not from Government as per VT Remarks. The same is not as per the NCTE Norms.
- V. As per VT Remarks the fixed deposits made on the personal name of the Secretary but not in the name of the institute.
- VI. The appointed teachers and the Principal are not qualified as per the NCTE Norms.
- VII. The Librarian does not have any qualification in Library Science as per VT remarks.
- VIII. It has appointed non-teaching staff more than the needs as per VT Remarks
- IX. As per the VT remarks a part of the building is under construction. In this regard the institution has not submitted any supporting document.



3. AND WHEREAS the institution preferred an Appeal to the Appellate Authority, NCTE-HQrs and the Appellate Authority vide order No. 89-1287/2009-Appeal / dated 5th Jan 2010 had remanded back the case to ERC-NCTE for issuance of letter of intent prior to recognition under clause 7 (9) of NCTE Regulations so as to facilitate the institution to complete the formalities related to the appointment of staff.

4. AND WHEREAS, as per the directions of the Appellate Authority, the Letter of Intent under clause 7 (9) was issued on 22nd Jan 2010.

5. AND WHEREAS upon consideration of the written representation submitted by the institution as well as documents as well as other documents and materials submitted by the institution along with application the Eastern Regional Committee in its 109th meeting held on 21st – 23rd June, 2010, came to the conclusion that recognition to the said institution be refused for the following reasons:

- (i) The institution shall launch its website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms, and other facilities/amenities), instructional facilities (laboratory, library etc.) and the particulars of their proposed teaching and non-teaching staff etc. with photographs. The downloaded copies of the website is required to be submitted.
- (ii) Principal of the institution not qualified as per NCTE norms.
- (iii) Requisite no. of teachers not qualified as per NCTE norms.
- (iv) The institution has proposed the Teacher education college at Khasra No. 4534 & 4535, measuring 0.31 decimals, whereas the Non-Encumbrance Certificate has been submitted for Khasra No. 462.
- (v) The application was received as per 2005 Regulations wherein the lease deed for a period of 30 years was permitted, but the institution has submitted the Rent Deed.
- (vi) The Rent Deed for Khasra No. 4534 & 4535 was executed on 12th Jan 2008 in the name of individual and another rent deed is executed in the name of institution on 25th April 2009 for the same plot. The two rent deeds have been executed for the same plot Nos. The institution has not submitted the cancellation document for the rent deed executed on 12th Jan 2008.
- (vii) In the rent deed executed on 12th Jan 2008, the institution has mentioned the land area as 0.31 decimal / 1500 sqm. Whereas in the rent deed executed on 25th April 2009 the land area is mentioned as 0.31 decimal / 2500 sqm.
- (viii) In the rent deed, it is clearly mentioned that the deed is for a Pucca House i.e. Residential plot.



- (ix) The FDRs submitted by the institution towards Endowment and Reserve Fund are in the name of Md. Rafiqi Alam Secretary Rashidiya Rani Sagri Teachers Education College i.e individual whereas it should be in the name of institution / Society.

6. AND WHEREAS the institution preferred an Appeal to the Appellate Authority, NCTE-HQrs against the said order of ERC and the Appellate Authority vide order No. No. 89-915/2010-Appeal/A26872 dated 25th October 2010 had reversed the ERC's order dated 29-06-2010 with direction to ERC to issue formal recognition order under clause 7 (11) of NCTE Regulations within 15 days of issue of the appellate order.

7. AND WHEREAS, the original file along with other documents, the order of the appellate authority, NCTE Act, Rules, Regulation and norms and Standards were placed before the Committee in 113th ERC meeting and the Committee decided that **as per the orders of appellate authority, order of formal recognition under clause 7 (11) of NCTE Regulations 2009 be issued.**

8. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee grant of recognition to **Rashidiya Rani Sagari Teacher's Education College, At – Chand Bajitpur, Po/Ps – Belaganj, Dist – Gaya, Bihar – 804403** for **PTT (D.El.Ed)** Course of **two years** duration with an annual intake of **50 students** from the academic **session 2010-2011** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations 2009 subject to fulfillment of the following:

- (i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cutoff date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012 only.
- (ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 200 teaching days the session is fulfilled as per the calendar of the University/Affiliating Body.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Eastern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.



(vi) The institution shall ensure that the required number of academic staff for conducting the course is always in position.

9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.


10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

13. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
