- (1) Minutes of 194th & 195th meeting confirmed with certain rectifications.
- (2) In 194th and 195th ERC Meeting, the ERC had inadvertently not issued the Show Cause Notice to new applicant institutions and rejected the applications directly, which is not appropriate as per the provision of NCTE Act 1993.
- (3) The instructions from the NCTE Hqrs New Delhi vide minutes of Regional Directors Meeting held on 11.10.2015 received on 12.10.2015 wherein clearly directed that such applications which were rejected without digital signature and signature on each page shall not be rejected and no show cause notice be issued. The NCTE Hqrs has also directed to re-consider and process such applications as per NCTE Act, Rules and Regulations.
- (4) It was also directed that Show Cause Notice be issued in case of non-submission of NOC, and NOC issued on or before 15th July, 2015 be accepted.
- (5) The ERC discussed about the basic unit of B.Ed. and D.El.Ed programmes. In case of D.El.Ed. the intake is pointed in the Regulations “*there shall be a basic unit of 50 students. Two basic units are permissible initially*”. However, Government institution shall be sanctioned a maximum of four units subject to fulfilment of requirement. For B.Ed. the intake is there shall be a basic unit of 50 students with a maximum of 2 units. The existing institutions are applying for additional units. The ERC is in need of clarification from NCTE Hqrs to process such applications treated as additional intake or reject due to crossing the limit of two basic units.

Keeping in view the above directions/omissions, the Eastern Regional Committee decided to re-consider the earlier decisions on the basis of legal opinion of Standing Council of NCTE in Hon’ble Supreme Court of India and decided as follows:
