In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Eastern Regional Committee grants recognition to Bethesda Primary Teacher Education College, Ranchi, Jharkhand for P.T.T. Course of Two years duration from the academic session 2002-2003 with an annual intake of 50 (Fifty) students, subject to fulfilling the following conditions:

- 1. The institution will ensure that Principal and 05 faculty members qualified as per norms are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
- 2. The institution shall, within one month of the receipt of recognition order, convert the endowment fund into a joint account to be operated along with an official of the Regional Committee.
- **3.** The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Govt. etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal/ Self-Appraisal Report at the end of each academic year along with a copy of the approval of the State Directorate of Education to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
