## <u>ORDER</u>

AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 339/13 in the Hon'ble Supreme Court of India against the said recognition order dated 04-May-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.
- 4. AND WHEREAS the Eastern Regional Committee in its 158 Meeting held on 23-24 July 2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 26-Jun-13 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Motiraj Devi Teachers Training College, Plot No. 113, 144, Vill/Po.
