Order

In terms of Section 15(1) of the NCTE Act, 1993 Loyola College of Education, River View Area, P.O. TELCO, Dist. Singhbhum, Jamshedpur, Jharkhand, Pin-831 004 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for the <u>B.Ed.</u> Course of <u>One</u> year duration with an additional annual intake of <u>20 (Twenty)</u> students from the academic session <u>2003-2004</u>.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - (i) The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has constructed the building for conducting the course on the above mentioned land.
 - (iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. 3.00 lakhs.
 - (iv) The institution has selected the Principal and 07 (seven) teachers for the said course and the list of faculty members has not been approved by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTF Act, 1993, the Regional Committee Reliefly grants recognition to Loyola College of Education, River View Area, F.C. TELCO, Dist. Singhbhum, Jamshedge, Jharkhand, Pin-831 004 for B.Ed. Course of One year duration from the academic session 2004-2005 with an additional annual intake of 20 (Twenty), thus with a rotal intake of 100 (one hundred) students subject to fulfillment of the following:
 - a. That the institution will ensure that Principal and at least 07 (seven) faculty members duly approved by the affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one mentil of commencement of the course.
 - b. The institution shall, within one month of the receipt of recognition programment the endowment that a account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - c. The institution shall provide one classroom with furniture for the additional intake of 20 students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month from the commencement of the academic session.
 - d. The faculty not having M.Ed./ M.A.(Education) shall acquire M.Ed. qualification within five years.
 - e. The institution shall comply with the various other norms and standards prescribed in the NOTE regulations.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- **6.** If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
