Sir.

The Eastern Regional Committee in its 85th meeting held on 28-29 March, 2008 noted that the institution was earlier granted recognition for B.Ed. course from the academic session 2005-2006 vide order No. ERC/7-60.6.7/2005/152-160 dated September 7/8, 2005 and later on the institution was directed not to admit students in view of complaints received against it.

- Further, the Committee considered the reply dated 4.3.2008 in response to 2. ERC clarification letter dated 31.12.2007 along with relevant documents, NCTE Act, Regulations and guidelines of NCTE published from time to time, summary report of Sub-Committee, both old and new NCTE Regulations, clarification letter dated 21.01.2008 received from NCTE Hars, and decided that as the institution fulfilis criteria laid down in the cld norms and regulations, it may be gratted permission to run the B.Ed. course in its existing building and allowed to take admission and examination of 100 (one hundred) students for B.Ed. course of one year duration from the academic session 2008-2009, for a period of three years. After completion of three years, the institution shall shift to its own building under intimation to ERC, NCTE and the institution will be re-inspected as per Clause 7(12) of Regulations, 2007 for which the institution shall deposit a fee of Rs.40.000/-.
- Further, the institution will ensure that the recognition is subject to 3. fulfillment of the following conditions:

The institution shall, within one month of the receipt of this letter. convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Eastern Regional Committee.
