CHANGE OF PREMISES OF THE INSTITUTION

Grizzly College of Education, Telaiya Dam, Dist.-Koderma, Jharkhand- 825413 (Code No.APE0799) granted recognition for conducting B.Ed. Course with an intake of 100 from the academic session 2009-2010 vide ERC order No.ERC/7-93.6(I).13/2009/15755, March 16th 2009 as per decision taken in the 93rd ERC meeting held on 25th–27th February -2009.

The aforesaid institution had submitted application dated 25th April 2012 for shifting of premises along with requisite documents, received at ERC, NCTE on 01st May 2012.

The ERC in its 154^{th} meeting held on $22^{nd}-23^{rd}$ April 2013 decided that VT to be constituted. Accordingly, the inspection of the institution at new premises was conducted on 24-Jun-2013 and VT Report received at ERC, NCTE on 17^{th} July 2013.
