WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Samarpan Deep B.Ed.  - e. Information for having fulfilled the norms & standard and other required conditions.
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order. The guidelines of appeal are enclosed herewith.
