WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Swami Sahajanand Saraswati B.Ed. College, Plot No. – 972 to 978, 1011-12, 1020 to 1054, Vill. – Bokaro Steel City, Po. – Sector 9, Tehsil/Taluka – CHAS, Town/City – Bokaro Steel City, Dist. – Bokaro, Jharkhand – 827009 has submitted an application **(Code No. ERCAPP1185)** to the Eastern Regional Committee of NCTE for grant of recognition for conducting **B.Ed Course** with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 9/29/2011 and hard copy of application submitted on (mm/dd/yyyy) 10/5/2011.

 - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
