ORDER**Change of premises of the institution**

S.B.M. Teacher's Training College, Masipiri, Po- Babhanbai, Dist.- Hazaribagh, Jharkhand-825301 (Code No. APE00873) granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No. ERC/7-100.6(II).5/2009/1336 dated 31.08.2009 as per decision taken in the 100th ERC meeting held on 26-28 August 2009.

The aforesaid institution had submitted application dated 30.09.2013 for shifting of premises along with requisite documents.

The ERC in its 185th meeting decided that VT to be constituted. Accordingly, the inspection of the institution at new premises was conducted on 14.05.2015 and VT report received at ERC, NCTE on 19.05.2015.

The ERC in its 189th meeting held on 27th -28th May 2015 after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., VTR, the Committee discussed the matter in detail and observed as under:

The institution viz S.B.M. Teacher's Training College, Masipiri, Po- Babhanbai, Dist.- Hazaribagh, Jharkhand-825301 (Code No. APE00873) had applied for shifting for premises to S.B.M. Teachers' Training College, Khata No. 01, Plot No. 1014 & 1015, street No.-NH 33 (Near Demotand), Vill/Po-Babhanbay, Tehsil/Taluka-Sadar. Dist.-Hazaribagh, Jharkhand-825301. The inspection of the institution for shifting of premises was conducted on 14.05.2015.

In view of the above the Committee decided as under:
Shifting of the institution is permitted to the new premise".
