In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application Baliapal College of Physical Education, P.O. Baliapal, Dist. Balasore-756 026 (Orissa) for grant of recognition to the B.P.Ed. course of one year duration, decided to accord one year conditional recognition for the academic year 2000-2001 with intake of 60 subject to removal of the following deficiencies:

- 1. The teachers are paid a consolidated salary of Rs.1700/- per month against the recommendations of NCTE for UGC/State Govt, scales.
- 2. Additional separate teachers should be appointed if the institution is running any other course in Physical Education.
- 3. The institution should acquire minimum 8 acres of land as per NCTE norms.
- 4. The institution should have hostel facility for at least 75% students on roll.
- 5. Facilities for indoor & outdoor, sports and physical facilities should be brought at par with the norms prescribed by the NCTE.
- 6. The sports medicine lab., education technology lab and health education lab. should be developed as per NCTE norms.
- 7. The institution should admit students with the eligibility prescribed in the NCTE norms.
- 8. The selection procedure for admission should be followed as prescribed in the NCTE norms.
- 9. Endowment fund and reserve fund should be maintained as per NCTE norms.

The institution is advised to send a compliance report about removal of the above deficiencies to the Eastern Regional Committee by 31.8.2000.
