

in exercise of the powers vested under Section 15(3) (a) of the National Council for Teacher Education Act, 1983, the Eastern Regional Committee grants permission to Govt. College of Physical Education, Kalinga Stadium, Bhubaneswar-751012 (Orissa) for starting B.P.Ed. course for the academic session 2001-2002 with an annual intake of 64 students in place of present recognized C. P.Ed. course which automatically ceases to be recognised with effect from 1.7.2001, subject to fulfilling the following conditions :

1. The institution shall ensure library, laboratories and other instructional infrastructure as per the norms.
2. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
3. Tuition fees and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
4. The practical work, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the affiliating university/examining body.
5. The number of hours of practice teaching should not be less than the number fixed in the NCTE norms.
6. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the **Annual Report by March 31st of every year** and the **Performance Appraisal Report** at the end of each academic year. The Performance Appraisal Report should give the extent of compliance of the conditions indicated at 1 to 5 above.

Further, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1983, the Eastern Regional Committee grants permission to Govt. College of Physical Education, Kalinga Stadium, Bhubaneswar-751012 (Orissa) to continue to follow the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, in order to fulfil the above conditions, the Regional Committee may withdraw this permission if the institution fails to comply with the provisions of Section 17(1) of the NCTE Act.
