WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, **Sister Nivedita D.Ed. 3. NOW, THEREFORE, in exercise of the powers vested under Section **14(3)(a)** of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **Sister Nivedita D.Ed. Training Institute, Plot NO. 3(R.S), 4 & 10 (L.R.), St. No.-N.H.31-C, Vill.-/P.O.-Kamakhyaguri, Tehsil/Taluka-Volka, Town/City-Kamakhyaguri, Dist.-Jalpaiguri, West Bengal-736202** for conducting **D.El.Ed. 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
