**ORDER**

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of D.I.E.T., Berhampore, Murshidabad (West Bengal) for grant of recognition to the Primary Teachers Training Certificate course of one-year duration, has decided to accord one year provisional recognition with effect from the academic year 1999-2000 with intake of 60 (Sixty) students subject to removal of the following deficiencies:

1. Principal's post should be filled and qualifications of all teaching staff should be as per NCTE norm.
2. Furniture and equipment position should be improved as per NCTE norm.
3. Curriculum transaction and supervised practice teaching should be as per norm.
4. Institution should have Educational Technology lab., workshop and Games room.
5. Principal should be provided with quarter.

The institution concerned is advised to send a compliance report about removal of deficiencies in respect of staff position by 30.6.99 and about other deficiencies to the Eastern Regional Committee by 31.12.99.
