ORDER

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Ramakrishna Mission Boys' Home Primary Teachers' Training Institute, Rahara, North 24-Parganas (West Bengal)** for grant of recognition to the **Primary Teachers' Training Course** of one year duration, has decided to accord provisional recognition for one year with effect from the academic year 2000-2001 with intake of **30 (sixty)** students subject to removal of the following deficiencies:

- (i) Six teachers in addition to the Principal qualified as per NCTE norms should be in position.
- (ii) Multipurpose laboratory should be developed.
- (iii) Practical work should be undertaken as per NCTE norms.
- (iv) Educational journals should be subscribed.

The institution concerned is advised to send a compliance report about removal of above deficiencies to the Eastern Regional Committee by 31.8.2000.
