**ORDER**

**Change of Premises of the institution**

Natural College of Education, Plot No. 380, Vill- Chora, PO- Karidhya, Tehsil/Taluka- Suri, Town/City- Suri, Dist- Birbhum, West Bengal – 731126 (ERCAPP1290), was granted recognition for conducting D.El.Ed. course with an annual intake of 50 from the academic session 2013-2014 vide ERC order No. ERC/7-158.15.1.7/2013/20137 dated 08/08/2013 as per decision taken in the 158<sup>th</sup> ERC meeting held on 18<sup>th</sup> – 19<sup>th</sup> March 2013.

The aforesaid institution had submitted application dated 18.05.2015 for shifting of premises along with requisite documents.

The ERC in its 205<sup>th</sup> meeting held on 20-21 February 2016, decided that VT be constituted. Accordingly, the inspection of the institution at new premises was conducted on 27.03.2016 and VT report was received at ERC, NCTE on 30.03.2016.

The Original VT Report, Video CD, all documents submitted by the institution was considered by ERC in its 210<sup>th</sup> meeting held on 7<sup>th</sup> – 9<sup>th</sup> April 2016, and wherein the ERC has made the following observations :

“ After considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act, the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time and VTR, the Committee discussed the matter in detail and decided as under:

➤ Shifting permitted.

In view of the above, the institution is hereby permitted for shifting of premises of the institution from “Natural College of Education, Plot No. 380, Vill- Chora, PO- Karidhya, Tehsil/Taluka- Suri, Town/City- Suri, Dist- Birbhum, West Bengal – 731126” to “**Natural College of Education, Plot No- 72, Vill- Krishnanagar, PO- Mahurapur, Ps- Mayureswar, Tehsil/Taluka- Rampurhat, Dist- Birbhum, West Bengal- 731218**”.
