WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Swami Vivekananda B.Ed. College, Plot No.-5955, Vill.-Chandrapur, P.O.-Chandrapur, Tehsil/Taluka-Chandrapur, Dist.- Birbhum, West Bengal-731131 has submitted an application (**Code No.ERCAPP1597**) to the Eastern Regional Committee of NCTE for grant of recognition for conducting **B.Ed Course** with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 12/28/2012 and hard copy of application submitted on (mm/dd/yyyy)12/31/2012.

2. 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **Swami Vivekananda B.Ed. College, Plot No.-5955, Vill.-Chandrapur, P.O.-Chandrapur, Tehsil/Taluka-Chandrapur, Dist.- Birbhum, West Bengal-731131** for conducting **B.Ed Course of Secondary** (level) of **one year** duration with an annual intake of **100 (one hundred)** from the academic session **2014-2015** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

4. The recognition is subject to fulfillment of the following:

 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

6. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order.
