Order

In terms of Section 14(1) of the NCTE Act, 1993 Institute of Science Education, Burdwan University, Rajabati, Golap Bag, Burdwan, West Bengal had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2000-2001 with an annual intake of 70 (Seventy) students.

2. The application was found incomplete and the applicant was asked to make good deficiencies before expiry of the last date prescribed for receipt of applications for further consideration. The applicant institution removed the deficiencies on 31.12.2001, by which time the last date for receipt of applications for the year 2001-2002 had already expired. On a specific request from the applicant, the application was considered by the Regional Committee for the year 2002-2003.

3. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has constructed the building for conducting the course on the above mentioned land.
- iii) The institution has selected the Head, 05 teachers and 15 Guest lecturers for the said course.

4. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Institute of Science Education, Burdwan University, Rajabati, Golap Bag, Burdwan, West Bengal for B.Ed. Course of one year duration from the academic session 2002-2003 with an annual intake of 70 (Seventy) students, subject to fulfillment of the following :

- a. That the institution will ensure that pending appointment of 07 full time faculty members within 03 years, as per state specific relaxation granted by Council to West Bengal for B.Ed. course, 05 faculty members and 04 Guest lecturers/part time lecturers are in position for an intake of 70 students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
- b. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Govt. etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal/ Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university / State Directorate of Education to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
