Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Eastern Regional Committee grants recognition to **Shree Ramakrishna B.T. College, 27, Gandhi Road, Darjeeling-734 101 (West Bengal)** for B.Ed. Course of one year duration **from** the academic session **2001-2002** with an annual intake of **60** students, subject to fulfilling the following conditions:

1. A qualified person as per NCTE norms shall fill up the post of Principal within six months.
2. The institution shall function with six teaching staff and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
3. Existing three teachers appointed after 17.8.95 and not qualified shall acquire the qualification as per NCTE norms within two years or be replaced with qualified teachers.
4. The institution shall ensure library with 3000 books, laboratories and other instructional infrastructure as per the NCTE norms within six months.
5. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
6. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
7. Curriculum transaction, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the affiliating university/examining body.
8. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
9. The institution shall maintain endowment fund as per NCTE norms within one year.
10. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 9 above.

If **Shree Ramakrishna B.T. College, 27, Gandhi Road, Darjeeling-734 101 (West Bengal)** contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.


