WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Jalangi B.Ed. College, Vill.-Narasinghapur, P.O.-Sagarpara, P.S.-Jalangi, Dist. Murshidabad, West Bengal-742306 has submitted an application (Code No: APE00670) to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration with an annual intake of 100 (One hundred only) students.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **Jalangi B.Ed. College, Vill – Narasinghapur, P.O.-Sagarpara, P.S.-Jalangi, Dist. Murshidabad, West Bengal- 742306** for conducting **B.Ed. Course of one year** duration with an annual intake of **100 (one hundred)** students under clause 7(10) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
