WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Debra Pramila Welfare Trust, Plot No- 108, 113, Vill- Chakmathkathpur, PO- Arjuni, Tehsil/Taluka- Kharagpr, Town/City- Debra, Dist- Midnapore, West Bengal- 721126 has applied for grant of recognition to Raipur Debra Kanailal Pal B.Ed College, Plot No- 108, 113, Vill- Chakmathkathpur, PO- Arjuni, Tehsil/Taluka- Kharagpr, Town/City- Debra, Dist- Midnapore, West Bengal- 721126 (Code No. ERCAPP3488) for B.Ed. programme online on 18.06.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 01.07.2015.

- 2. AND WHEREAS, inspection team was constituted by ERC-NCTE, which visited the institution on **04.03.2016** to verify infrastructural and instructional facilities provided by the institution and also the essential documents as per NCTE Regulation.
- 3. AND WHEREAS, the ERC in its 210th meeting was held on 7th 9th April, 2016 considered the VT Report, Video CD along with original file of the institution and as decided, Show Cause Notice u/s 14(3)(b) was issued vide No. 46975 dated 03.06.2016 to the institution on the following grounds:
 - (i) As per building plan and building completion certificate, there is four storied building but as per CD only two storied building are available.
 - (ii) As per building plan and building completion certificate, total built up area is 3199.62 Sq. Mts. whereas as per VT report built up area is 1300 Sq Mts.
 - (iii) Class rooms and furniture are inadequate.
- 4. AND WHEREAS, the institution submitted reply vide letter dated 15.12.2016 received in ERC, NCTE on 28.12.2016. The ERC in its 234th meeting held on 27th February to 3rd March, 2017 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act, the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time, discussed the matter in detail and observed as under:
 - a. SCN was issued on 03.06.2016 on the following grounds:-
 - (i) As per building plan and building completion certificate, there is four storied building but as per CD only two storied building are available.
 - (ii) As per building plan and building completion certificate, total built up area is 3199.62 Sq. Mts. whereas as per VT report built up area is 1300 Sq Mts.
 - (iii) Class rooms and furniture are inadequate.
 - b. In reply, the institution vide representation dated 15.12.2016 stated that they have completed two storied building.
 - c. There is no provision for re-inspection of the institution as per NCTE Regulation, 2014.

In view the above, the Committee decided as under:

The committee is of the opinion that application bearing Code No.ERCAPP3488 of the institution regarding recognition of B.Ed. Programme is hereby refused under section 15(3)(b) of NCTE Act 1993.

- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
