**ORDER**

**WHEREAS**, in terms of Section 15(1) of the NCTE Act, 1993, Samajik Pragati Mahila Vikas Manch Patna, Plot no.4873, St/Rd-Digha Gate no. 87, Vill-Makhdumpur, Po-Digha, Tehsil/Taluka-Makhdumpur, Town/City-Patna, Dist-Patna, Bihar-800011 has applied for grant of recognition/permission to **Vidya College of Professional Studies, Plot no.-410,411, Vill-Rasulpur Varuna, Po-Chipura, Tehsil/Taluka-Sampatchak, Town/City-Patna, Dist-Patna, Bihar-804453 (Code No.- ERCAPP3171)** for additional intake in **D.El.Ed. programme** online on **30.05.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **04.06.2015**.

2. **AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. **AND WHEREAS**, as per the decision of 207<sup>th</sup> ERC meeting held on 1<sup>st</sup> – 3<sup>rd</sup> March, 2016, formal permission order under clause 7(16) was issued vide No. 44316 dated 03.03.2016 with an **intake of 50 (one basic unit)** from the academic session **2016-2017** to the institution.

4. **AND WHEREAS**, the institution, being aggrieved with the decision of ERC, filed Writ Petition bearing No. W.P.(C) No. 9124 of 2016 before the Hon'ble High Court of Orissa and the same matter was placed in 225<sup>th</sup> ERC Meeting held on 16-18 November, 2016. The Committee decided that the prayer of the Petitioner to accord revised recognition for the required another one unit is not at all possible at present as the cut of date for grant of recognition is over for the session 2016-2017 and in no circumstances, the same can be taken for consideration. As such the application of the petitioner for grant of recognition/permission for another one unit stands disposed of and it is open for the applicant to make afresh application as per NCTE Regulation, 2014 for the next academic session for consideration.

5. **AND WHEREAS**, The institution has submitted representation dated 25.04.2017 along with D.D. of Rs. 1,50,000/- and a copy of the Order passed in Writ Petition bearing W.P. No. 22418(w) of 2016 by the Hon'ble High Court of Orissa. The Hon'ble High Court disposed of the matter on 18.04.2017 with a direction interalia:

*"We dispose of this writ petition with the direction that although the time for filing of the application for the academic session 2017-18 has already expired, but in case*

the said application, along with requisite fees and necessary documents, is filed by the petitioner with the opposite party No. 1-NCTE along with certified copy of this order on or before 25.04.2017, the same shall be treated as fresh application filed within time, and shall be decided on its own merit and necessary orders for intake of students in the institution of the petitioner for the academic session 2017-18 shall be passed in accordance with Law."

**In view of the above, the Committee decided as under:**

In addition to 50 intake already granted from the academic session 2016-2017 earlier, the Committee decided that formal recognition Order under clause 7(16) of the NCTE Regulation, 2014 for applied **D.El.Ed.** programme with another **50 intake** from the session **2017-2018** be issued to the institution, thus making the **sum total grant of 100 intake.**

6. **NOW THEREFORE**, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to **Vidya College of Professional Studies, Plot no.-410,411, Vill-Rasulpur Varuna, Po-Chipura, Tehsil/Taluka-Sampatchak, Town/City-Patna, Dist-Patna, Bihar-804453** for conducting **D.El.Ed.** programme of two years duration with an another intake of **50 (one basic unit) i.e. (existing 50 intake + another 50 intake), thus making the total intake of 100 (one hundred)** from the academic session **2017-2018** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


9. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a) Sanctioned programmes along with annual intake in the institution;

- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last quarter;
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application;
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available list of students admitted on its official website.
12. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
13. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
